Many of our activities are focused on advocating for our members and their patients during the pandemic, but we are managing to get some other initiatives off the ground as well.

Thank you to Monique Soileau-Burke, Rachel Dodge and Celestino Menchavez for resuming our COVID-19 and Its Effect on Private Practice Pediatricians meetings. On October 19<sup>th</sup> we talked about concerns regarding PPE availability and had an excellent discussion with Drs. Geoff Rosenthal and Yvette Rooks on cardiac clearance for athletes who have had COVID-19. We also sent out a **very brief survey** to members regarding SARS-CoV-2 testing capacity. This information is **critical** to help us advocate at the state level for pediatric support including availability of PPE and pediatric testing sites. Thank you to those of you who completed this!

Turning out attention from the pandemic, on October 26 we had our kick off for our family engagement grant. The goal of this grant is to find a way to engage family and possibly youth representation in the chapter. We had two excellent speakers, Pattie Archuleta from the Maryland Coalition for Families and Stacy Taylor from the Office for Genetics and People with Special Healthcare Needs in the Maryland Department of Health. We were also joined by members of other state chapters who have successfully integrated families. The Pritzker Children's Initiative funds collaboratives in 21 states to improve early childhood services. We have been chosen as one of 4 states who will be partnering with our Pritzker collaborative headed by the Maryland Family Network to improve collaboration between early childhood services and pediatricians. Goals include supporting medical home capacity, increasing referrals to early intervention, and educating parents about the importance of early childhood for healthy development. We

Legislative session is around the corner. The session will be virtual, and we anticipate legislation around telehealth. The Maternal Child Health task force completed its work this summer with Mel Stern as our representative, and one of the recommendations was to make MCH the 3rd goal in population health for Maryland's Improvement strategy with CMS and to create a standing MCH committee in the MDH. Both are in the works. Our Tuesday night legislative calls will start in January, so keep an eye out for the information from Loretta.

At our general membership meeting on October 15<sup>th</sup>, we heard from the Baltimore City Health Department regarding their flu initiative; from CRISP regarding a new Infants and Toddlers alert for high risk conditions and an optional immunization alert; and from the McKibben Group regarding information on safe gun storage for families.
